What is the difference between Ofqual Vocational Qualifications & ABT or CPD courses?

CPD is known as 'Continued Professional Development' training courses are there for people within the industry to completed and stay up to date with new methods and new treatment which come out. With CPD or accredited courses there is no regulations with regards to the content of the subject matter, due to this it is really important to pick a training provider who does their own quality assurance and offers continued support. CPD courses are accredited courses which are fully insurable after training, they were initially made available to learners who had already completed an Ofqual Qualification as a way of doing 'continued professional development' in a particular subject matter, whether that was hair, beauty, barbering etc.

Over the years they have now been made available to everyone, meaning that you can attend courses with no prior experience and still gain your insurance, this is great in some ways, you may not be the studying type, you just want a little side job around the kids or your current job, this has made it a great route for people that are passionate about beauty but could never go to college to study the level 2 or 3 beauty.

However, there can also be some cons, such as the learner leaving without actually gaining much knowledge as the training centre is not regulated or just doesn't care if the student actually learns anything, unfortunately a lot of learners can leave feeling confused and with little to no aftercare support.

Regulated Qualifications are there for learners to meet the criteria and reach the correct level, to give them the education and knowledge to work professionally within the industry and progress onto further training.

What is the difference between Ofqual Vocational Qualifications & ABT or CPD courses?

Ofqual - The Office of Qualifications and Examinations Regulation (Ofqual) regulates qualifications, examinations and assessments in England. They are the regulator body that Awarding Organisations such as VTCT, TQUK, CIBTAC, Qualifi, Proqual, Focus Awards etc and they all have to answer to and comply with. Ofqual is the only government recognised qualification.

Ofqual set the qualification standards for:

- GCSEs
- A levels
- AS levels
- vocational and technical qualifications
- Apprenticeship end-point assessments

Therefore, when choosing an Ofqual regulated qualification you will have a certain amount of guided learning hours to complete your training & feel fully confident once you have passed. You will need to complete assignments, complete practical assessments on more than 1 client, which will only be passed once you're at salon standard.

Unfortunately, I have had countless students come to me with level 3 or level 4 qualifications which are not worth the paper they're written on and are accredited courses that a training academy has written up themselves, this is not a Qualification and is not recognisable in the Education sector, although you could still gain insurance. If you are ever unsure of the Qualification you have received always look for the Ofqual emblem on your certificate.

What is the difference between the Qualifications

You will notice that some qualifications are an 'award', 'certificate' or 'diploma' the difference in these are set out below

A level 3 Award is usually a smaller qualification with one to three units that usually around 30-40hrs learning time

A Certificate is again slightly longer with more guided learning hours, with 2 or more units to cover.

A Diploma is the highest qualification in the 'levels' which can be gained, training with around 100+ guided learning hours and 4 or more units to cover.

All of these Qualifications are still Ofqual approved and regulated – they are awarded based on guided learning hours and the amount of credits gained from the Qualification.

Qualifications are set in levels, some courses you can go straight in at a level 4 if you already have prior learning in that subject area.

The vocational qualification being offered, including the units are set out in this training prospectus.

Whether your qualification is classed as an Award, Certificate or Diploma, they are all Ofqual regulated & one isn't better than the other, generally therapists work up the ladder in 'levels'.

So why upgrade to a Qualification?

The reason therapists would upgrade to a level 3 or level 4 is to have a more recognisable qualification, or simply to learn more.

Upgrading also future proofs your career, new regulations will be coming to the industry soon and ensuring you have a regulated qualification ensures that you can continue working without disruption.

For instance, if you're offering a lot of facial treatments the Level 4 Skincare will give you so much more knowledge on the skin.

As the industry is starting to become more regulated Licences by your local councils are being brought into effect. When this happens they will want Ofqual regulated qualifications, this has already been brought in by many boroughs in London and is starting to filter out. Meaning if you do not have the qualification they can refuse you a licence, meaning you can gain insurance, but could not legally work if you need a licence. It is always best to check with your local authority.

If offering more advance treatments such as fillers and botulinum toxin is on the horizon for yourself, having a level 4 qualification is a must to then progress onto your level 5, 6 & level 7 aesthetics.

Having an Ofqual regulated qualification keeps you at the highest industry standard.

Training

With these Qualifications depending on which qualification you sign up for & depending on what experience you already have will depend on how many days/weeks/months you will need to attend the salon for practical training or theory work. Some courses may be home based and you only need to attend 1 practical day, whereas others you may need to come in for 1 day a week for 6 months (such as the Level 4 Skincare).

With all qualifications you will need to sit practical assessments, assignments & professional discussions.
